ORDER UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT-2005

In continuation to this office Order No. 2-49 dated 01st January 2021 and in exercise of the powers vested in me under Section 34 of the Disaster Management Act 2005, I, Rakesh Kumar Prajapati, District Magistrate, Kangra at Dharamshala, do hereby order and direct, in the interest of protecting the health and safety of public at large that:-

- sale/purchase/export of any poultry / birds / fish of any breed/age and their related products (eggs, meat, chicken etc.) shall be completely prohibited within the area under the jurisdiction of Sub Division Fatehpur, Dehra, Jawali and Indora of District Kangra;
- ii. slaughter of any poultry/birds/fish of any breed/age shall be completely prohibited in all slaughter houses or in home or in any place within the area under the jurisdiction of Sub Division Fatehpur, Dehra, Jawali and Indora of District Kangra;
- iii. all shops/farms involved in sale or purchase or export of any poultry/birds/fish of any breed/age within the area under the jurisdiction of Sub Division Fatehpur, Dehra, Jawali and Indora of District Kangra shall remain closed;
- iv. no movement of humans (locals/tourists or any) shall be allowed within the 1 k.m radius of Pong Dam or alert zone declared by the District Administration except those related to deal/manage with the suspected Avian Influenza Outbreak or permitted by the District Administration;
- v. no movement of livestock or domestic animals for the purpose of grazing or any shall be allowed within the 1 k.m radius of Pong Dam or alert zone declared by the District Administration and Deputy Director Animal Husbandry, district Kangra shall deploy adequate staff to monitor/check the grazing activities within the prohibited area and if required may request state government to provide additional staff from other districts;
- vi. all agriculture or horticulture related activities will be prohibited within the 1 k.m radius of Pong Dam or alert zone declared by the District Administration and Deputy Director Agriculture and Horticulture, district Kangra shall deploy adequate staff to monitor/check the agricultural/horticultural activities within the prohibited area and if required may request state government to provide additional staff from other districts;
- vii. Chief Conservator of Forest, Wild Life, North at Dharamshala will ensure the quick burial/disposal/of dead birds and disinfection of infected area under their area of jurisdiction, surrounding or outside the area of pong dam in district Kangra, whereas beyond the jurisdiction of Forest Department the aforesaid burial/disposal of dead birds and disinfection of infected area shall be ensured by the Deputy Director Animal Husbandry, district Kangra, and both Chief Conservator of Forest,

Wild Life, North at Dharamshala and Deputy Director Animal Husbandry, district Kangra shall constitute Rapid Response Teams (Fully equipped with PPE and sanitization materials) for the aforesaid purpose;

Chief Conservator of Forest, Wild Life, North at Dharamshala will ensure viii. maintenance of record of mortality or sickness of birds under their area of jurisdiction, surrounding or outside the area of pong dam in district Kangra, whereas beyond the jurisdiction of Forest Department, records shall be maintained by Deputy Director Animal Husbandry, district Kangra;

Chief Medical Officer, Kangra at Dharamshala shall ensure stockpiling of necessary medicines, PPE Kits and keep vigil of the human transmission of the suspected Avian ix. Influenza and also keep ready the details of the testing labs for Avian Influenza;

the practice of offering feed to birds/fish shall be prohibited within the area under the jurisdiction of Sub Division Fatehpur, Dehra, Jawali and Indora of District X.

any person (whether natural or juristic) who violates or abets the violations of this order shall be liable to fine of upto Rs. 50,000/- for every such violation in addition xi. to prosecution under relevant sections of law and the powers to levy and recover such fine shall vest with Superintendent of police, Kangra, and Sub Divisional Magistrate, Fatehpur, Dehra, Jawali and Indora.

THIS order shall come into effect immediately and shall remain valid till further orders;

- 15)All members of ULB and PRI for wide publicity at local level.
