ORDER UNDER SECTION 144 Cr.P.C .

In partial amendment to this office order no 1501-1550 SK/DM, dated 20th April, 2021, I, Rakesh Kumar Prajapati, IAS, District Magistrate, Kangra at Dharamshala in exercise of the powers conferred in me under section 144 of Cr. PC, and in welfare of the public at large, do hereby order and direct that:

Home Isolation/Quarantine and COVID-19 testing


- i. In case of violation of the guidelines/directions of Home Isolation by any person, the concerned Ward Member/Pardhan/Up Pardhan/Councilor of M.C./Chairman M.C/Vice Chairman M.C or any other officer/official designated by Sub Divisional Magistrates shall be authorized to register case under the appropriate provision of law stated in the order no 1501-1550 SK/DM, dated 20th April, 2021;

Exempted category

- i. Shops dealing with items of daily need such as fruits, vegetables, milk shops, pharmacies shall be exempted from the weekend lockdown i.e. on Saturday and Sunday and all restrictions of night curfew i.e. from 8.00 P M to 06.00 A.M shall be imposed, whereas sweet shops/confectioner selling milk or milk products shall not be covered under exempted category
- ii. Government/ Private hospitals/ Pharmaceutical/ Veterinary hospitals/ health related manufacturing units / their ancillaries together with transportation related activities / food processing units.
- iii. Hotels within the jurisdiction of district Kangra shall be exempted from all restrictions whereas the restrictions of night curfew and weekend lockdown shall be imposed on restaurants/ dhabas and eateries.

THIS order shall come into force with immediate effect in the entire territorial jurisdiction of Kangra district and shall remain valid till further orders.
